### **FDSE.05 Applicability**

(a) This Regulation lays down detailed rules for:

- (1) Flying Displays and Special Events at MOD establishments in the NL;
- (2) Flying Displays and Special Events at non-MOD establishments in the NL where the only participants are military aircraft;
- (3) Flying Displays and Special Events at non-MOD establishments in the NL where the participants are civil and military and the Display Director has been tasked by the MOD.

(b) This Regulation shall apply to:

- (1) Military organisations and -management of Flying Displays and Special Events in the NL;
- (2) Military participants of Flying Displays and Special Events in the NL.

(c) This regulation is based on NATO STANAG 3533 Flying and Static Displays and the national civil regulation *regeling Luchtvaartvertoningen*.

### **FDSE.10 Definitions**

Definitions are published in NLD-MAD-1 Military Aviation Document, Definitions and Acronyms.

### **FDSE.15 Flying Display Organisation and Management**

(a) All Flying Displays shall be managed, organised and executed in order to reduce the Risk to Life to at least As Low As Reasonably Practicable (ALARP).

(b) All Military Flying Displays shall be notified in advance to the MAA-NLD.

### **FDSE.20 Display Flying, Role Demonstrations and Flypasts (Mil)**

The Director of Operations of the Royal Netherlands Air Force shall ensure that aircrew participating in Flying Displays, and Special Events are appropriately trained, approved, authorised and supervised.

### **FDSE.25 Separation Distances, Minima and Restrictions**

Authorised minimum vertical and lateral separation distances, and other applicable minima and restrictions shall be complied with at all times during Display Flying, Role Demonstrations and Flypasts.

### **FDSE.30 Entry into force and application**

This Regulation shall enter into force on 1 September 2021.
