#### Approach to Delfzijl harbour

The harbour is under normal conditions accessible to vessels with draughts up to 9m, making use of the tide. A under keel clearance of 10% must be allowed. The harbour is approached through Paapsand Süd fairway using the 203° leading line and Knock sector light (at night).

The above-mentioned fairway is deepest on the W side. On the E side an bank extends into the fairway. During the ebb stream deep-draught vessels may therefore have insufficient water to enter the harbour safely. The tidal stream runs across the harbour entrance. For vessels with a length of 150m or more and/or a draught of 8m or more the best time to enter, is therefore the time of slack water. When entering during the ebb care must be taken the moment the breakwaters are passed.
